PROOF OF RESIDENTIAL STATUS PRIOR TO ENROLMENT

Please provide the following **original** documentation when attending your interview for your child's enrolment at Harrington Street Public School or Preschool. **In the event that statements or documents provided as part of this application later prove to be false or misleading, any decision made as a result of this application may be reversed.**

1. Council Rates or Residential Lease or Rental Agreement

Council rates (the owner).

OR

Residential Lease/Bond/ Rental Agreement (if you are renting through a Real Estate Agent)

2. If you are **NOT** the owner or leasee of the property and are renting privately, then you need to provide:

***the **owner's** Council Rates Notice **OR** Residential Lease **OR** Bond Agreement and complete

a **STATUTORY DECLARATION** stating who is the owner/lease and where you live.

(It should be witnessed and signed by Justice of the Peace.)

ALSO Please provide at least **three (3) documents** with your current address from the list below:

Electricity or gas account

Water or telephone account or other bill

NSW Driver's Licence;;

Car registration and car insurance policy;;

Tax Assessment notice or Centrelink card.

Bank Statement

3. Please provide the following **additional documentation**:

Birth Certificate of child *(if child born in Australia)* or **Passport** *(if child born overseas)*.

Parents Australian Citizenship Certificate or **Passport and Visa** *(if parent born overseas)*.

Temporary visa holders – authority to enrol issued by Temporary Visa Holder's Program Unit.

Immunisation history statement – (Visit Medicare or call 1800 653 809 to obtain your copy)

Medicare card.

Doctor's name, address & telephone number.

Two (2) emergency contact names, phone numbers, mobile numbers & relationship to student.

ASCIA (Australian Society of Clinical Immunology and Allergies) Individual Health Care Plans for Allergies, Anaphylaxis and/or other medical conditions such as Asthma, completed by the doctor.

Low income health care card (If applicable).

Family law, DVA or court orders relating to the child *.(if applicable)*

SCHOOL CHECKS. Verification of documentation may be sought by the school from other government agencies.

If a person provides materially false or misleading information to a school when making an application for enrolment, this is an offence which has a penalty of up to 2 years imprisonment, \$22,000 fine or both – section 307B of the Crimes Act 1900. (NSW Department of Education and Training Legal Issues Bulletin 24 December, 2007.)
